



Campership Subsidy FAQs

1. What is the Campership Subsidy Program?

The Campership Subsidy Program provides financial assistance to families who need support to send their children to camp. Subsidies cover a portion of the camp fees, making the camp experience more accessible.

2. Who is eligible to apply for the subsidy?

The program is open to families who demonstrate financial need. Applicants must provide proof of income to be considered.

3. How do I apply for the subsidy?

Applications are available online only. Complete the form and upload the necessary documents by the deadline of December 15.

4. What documents do I need to submit with my application?

You will need to submit one of the following:

- Canada Revenue Agency Notice of Assessment
- Pay stub(s) from the most recent month
- Other proof of income

5. What is the timeline for the application process?

- Application Opens: November 14, 2025
- Application Deadline: December 14, 2025
- Notification of Approval: By December 23, 2025
- Deadline for families to confirm subsidy use: January 9, 2025

6. How many subsidies can my camper receive?

Each camper is eligible for one camp subsidy per year.

7. Will the subsidy cover the full cost of camp?

Subsidies typically cover a portion of the camp fees. If you choose to accept the subsidy and register your child for camp, each family is required to pay a minimum registration fee of \$50 per child, regardless of the subsidy amount.

8. What is the policy regarding the registration fee?

The \$50 registration fee is non-refundable and non-transferrable.

9. What is the cancellation policy?

- Cancellations made up to 30 days before the program start date: Full refund minus a \$50 administration fee.
- Cancellations less than 30 days prior to the program start date: No refunds unless a doctor's note is submitted.
- No refunds for campers sent home for any reason once the camp session has begun.
- Camp Yowochas reserves the right to cancel programs due to insufficient registration or to
 ensure the health and safety of campers and staff. In such cases, a full refund will be
 provided.

For subsidized campers, cancellations will only result in a refund of the amount they paid, excluding the \$50 registration fee. No refunds will be issued for the subsidy amount.

10. How will I be notified if my application is successful?

Families will be notified via email by December 23. Please ensure the email address in your application is correct, and remember to check your spam or junk folder.

11. What happens after I receive a subsidy approval?

After receiving a subsidy approval, you must confirm by the January 9 deadline if you will use the awardeda mount. Once you accept the subsidy and agree to pay the remaining balance by April 30, YWCA Camp Yowochas will register your child(ren) for summer camp.

12. Can I pay the remaining camp fees in installments?

Families can make payments of any amount toward their account anytime from registration up until camp. The full balance is due by April 30, 2026.

13. Is my personal information kept confidential?

Yes, all personal information submitted is handled in compliance with privacy laws. It is used solely for the purpose of processing your application and will not be shared with external parties.
